INSTRUCTIONS FOR VISA APPLICATION

Enclosed, please find a visa requirement form.

An application falling within the category of countries whose citizens do not require a visa to enter Zimbabwe need only have:

1. A valid passport having at least 6 months validity
2. A round trip ticket and
3. Sufficient funds for their stay

If an applicant should require a visa, the attached Visa Application Form should be completed in full and returned to the Embassy of the Republic of Zimbabwe, as per address below, together with **passport, two passport size photos, a pre-paid return courier envelope and a Money Order** (issued under the name of **Embassy of the Republic of Zimbabwe**)

Please note that the Entry Visa will be valid for **six months from the date of issue** and will take up to **10 working days** to process.
